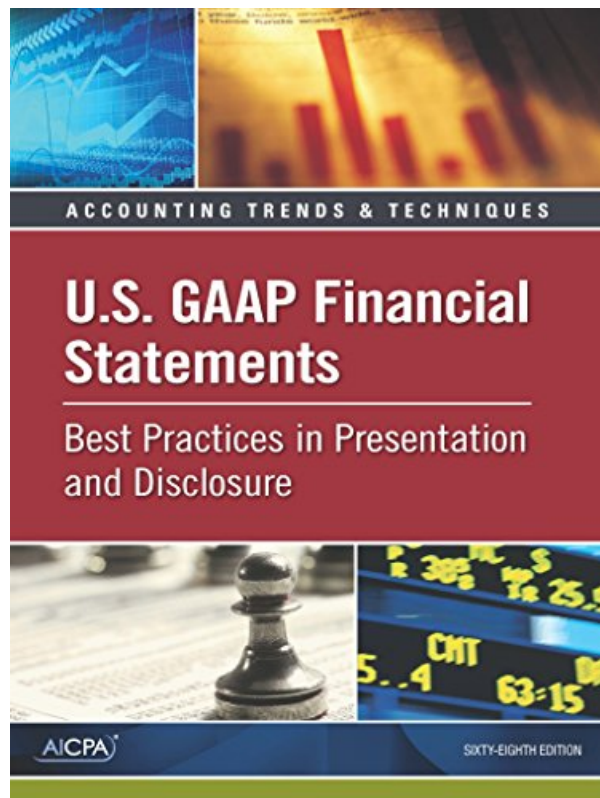
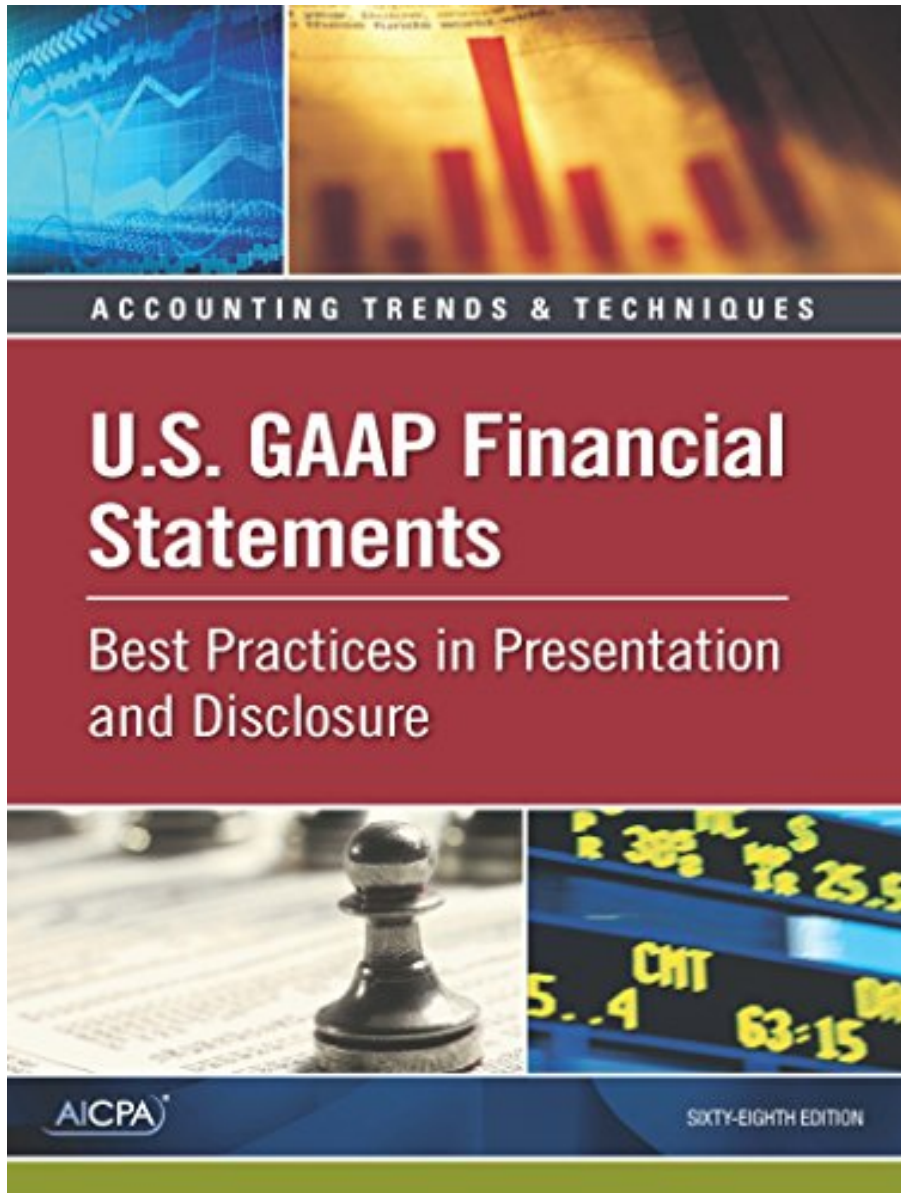

I have been ordering Accounting Trends & Techniques every 2-3 years to see what accounting methods and disclosures companies are using. The book at one time reviewed 600 firms and then 500 firms. The book indicated how many firms used various accounting methods (FIFO, LIFO, etc). Evidently the 2012 edition changed to reviewing 350 firms but does not disclose the use of various methods. Only the actual disclosures from a particular company(ies) is shown. There are no tables giving the number of companies that use a particular method or entered into a particular transaction (such as issuing a stock dividend). I do not find this edition as useful.
